## Here's How You Can Help

- Enclosed is a nominating petition for Joseph. Please sign it. Ask other registered voters in your household to sign it. Ask your neighbors to sign it as well.
- Remind people that only registered Democrats of New Mexico may sign. They should sign in blue or black ink and their name and address must appear on the petition exactly as it does on their voter registration form.
- People may sign only ONE petition for State Auditor. Signing multiple petitions for State Auditor will invalidate their signature on all petitions. Also, let people know that signing a petition does not commit them to vote for any particular candidate. It just helps that candidate get on the ballot.

## Petitions Due January 20, 2022

Please return all signed petitions by January 20, 2022. You can use the enclosed self-addressed envelope. It's not necessary that the petition is fully filled out. For example, maybe you've only gathered 6 or 7 signatures on the petition. That's okay. Simply return the petition, with however many signatures you've gathered, by January 20, 2022. Every signature counts!
